# **Noise Ordinance Summary**

## **Decibel Level Violations**

New Lower Standards for Residential Zones

- 50 dBA 9 pm to 7 am
- 60 dBA 7 am to 9 pm

Same Decibel Procedures as Before

- Requires officer measured dBA reading
- Reading taken from boundary of Noise Sensitive Unit (NSU)
- 50 dBA 9 pm to 7 am NSU (Night)
- 60 dBA 7 am to 9 pm NSU (Day)
- 60 dBA 9 pm to 7 am Non-NSU (Night)
- 75 dBA 7 am to 9 pm Non-NSU (Day)

## **Exemptions**

- Organized group activities on public property (i.e., stadiums, schools, and athletic fields)
- Emergency equipment/vehicles
- Properly functioning alarm systems
- Sounds permitted by government regulation (e.g., railroad or aircraft sound)
- Construction activities from 7 am to 9 pm
- Sounds from vehicular traffic on premises open to public
- Sounds related to religious services/holidays
- Sounds from an event at a City park where a Park Use Permit has been issued
- Sounds otherwise permitted by law

# Non-Decibel Violations

Noisy Animals

- Heard any time of day
- Repetitive noise
- Continuous for 10 min. or intermittent for 30 min.
- Heard beyond boundary of owner/keeper's property

Noise Heard within Noise Sensitive Unit (NSU) – Night

- Noise coming from device designed for sound production
- Heard -9 pm to 7 am
- "Plainly audible" from within NSU

Noise on Public Property

- Noise coming from device designed for sound production
- Heard anytime
- "Plainly audible" from at least 100 feet from the device

Construction/Power Tools/Engines

- Not permitted from 9 pm to 7 am (Night)
- Permitted from 7 am to 9 pm (Day)
- Decibel level does not matter
- Night use requires City permit

### Private Party Complaint

- Must be non-decibel based
- Must sign Certification form
- Description must summarize evidence of a violation
- Signing party is subject to False Certification
- Party must agree to come to court

#### Responding to Noise Complaints

"NSU" - Noise Sensitive Unit: Any authorized land use of a church, temple, synagogue, day care center, hospital, rest home, retirement home, group care home, school, dwelling unit (single-family dwelling, duplex, triplex, multi-family dwelling, or mobile home) or other use of the same general type, and rights-of-way appurtenant thereto, whether publicly or privately owned.
